Rotary also partners with the YMCA in the Night Study Centres where students who live in small tenements come to study in a quiet, congenial atmosphere under the supervision of teachers. The Rotary also provides much needed nutritional snacks.

Paul proudly shared the excellent SSC results achieved by these kids.

Once again, an initiative that has worked over decades, sustained by the dire needs it fulfils!

#### SHARVIL PATEL, MANAGING DIRECTOR, CADILA HEALTHCARE ON RECENT APPROACHES TO TREATING COVID – PREVENTIVES TO THERAPEUTICS

Although I am a vaccine manufacturer and developer, **vaccines alone will not be the answer** for us to get out of the pandemic. We will need vaccines and other solutions, including therapeutics and faster diagnostics or better diagnostics.

The virus is mutating fast. One hopeful answer to this would be that with multiple mutations, hopefully, over some time, the virus will become less immunogenic and less harmful and then become the regular kind of flu virus in the future. We hope that as the mutation continues, the virus will lose its virality and become less neurological.

The vaccine we have under development is under the approval stage with the regulators. **We have developed our platform entirely by ourselves.** We have not relied on partnerships or licensing technologies. Hopefully, this will be the first DNA platform that gets fully approved for vaccination for any viruses.

We need to pivot more on the discovery side because we won't find answers in the West every time. We already know that it is difficult to source some of the vaccines from India. So, we need to be self-reliant not only in vaccines but other medications too. We need to do our own discovery and innovation to answer diseases that are more frequent and critical for countries like ours and for some of the nations near us.

## **ROTARIANS ASK**

Why do we need a booster dose for Covid every year?

Three reasons: 1) In people infected with Covid or who are vaccinated, anti-bodies are seen waning after six months. So if you look at neutralising anti-bodies, they are also coming down. 2) The virus is mutating and escaping the current form of vaccines. So, **in future, maybe you need a vaccine or a cocktail of vaccines for the dominant strain.** I think the virus is moving towards a direction where you may not get 90 per cent immunity to it, that is why some vaccination may be required to minimise the severity of infection.

If, hypothetically, everyone in the world takes the vaccine, is it the end of covid?

I don't think Covid would be gone if everybody is vaccinated because the virus is mutating and escaping the current vaccines. You can protect yourself from the severity of the infection. There is no answer, but the cases will come down, and deaths will come down.


## RCB NBOX

Masina Hospital has launched a course in geriatric and dementia care, for young adults. The course, supported by RCB, is designed in collaboration with Tata institute for Social Sciences and Alzheimer's and Related Disorders Society of India.

#### The goal is to create well-trained care-There givers. modules in are gerontology, nursing psychological care, physiotherapy, care, occupational therapy, and Dementia care.

Eligibility for the course is young adults from ages 18 to 45 who have passed, at least, their 12<sup>th</sup> standard. Apart from efficient care for elders, the course will also benefit unemployed youth who need work.



President Shernaz Vakil's first official visit as President was to the Vocational Training & Night Study Centre earlier last week.

Night Study Centres, a joint initiative of the Rotary Club of Bombay and Bombay YMCA, was started in 1966 in a Municipal School to support young boys and girls in their school education. NSC is a place where the students, who live in very small tenements, come to do their homework and study. Bombay YMCA's Outreach and Development Department evolved slowly out of the concern for the poor, marginalised and vulnerable classes and has diversified from education to capacity building and promoting equal opportunity.

The NSC in south Mumbai caters to over 550 children through 16 centres. A class of 30 students is provided with teachers in the nonschooling hours between 7 to 9 pm for the ages above 8 years. RCB provides nutritional food and supplements. The students have continued to use this facility at graduation and even post-graduation level. Students who have studied at the NSC have become doctors, lawyers, IT professionals which makes our work and mission immensely satisfying as a genuine need has been fulfilled.

**RCB's heart beats for four-yearold:** Master Hemant Naik, aged 4, was referred to Kokilaben Ambani Hospital for a heart surgery. He had Hypoplastic Left Heart Syndrome (HLHS) and had already undergone four balloon procedures and an open-heart procedure at Wadia hospital.

He needed the Fontan procedure, complicated surgery with а a high risk. The parents were explained the risks before surgery and counselled. In the end, the surgery was successful, and the child has gone home. The parents live in Kamrajnagar, off Eastern Express Highway, Ghatkopar, which is pre-dominantly a slum area. Expenses amounting to Rs 2.75 lakh were paid by the Rotary Club of Bombay under the Global Grant. The additional expenses towards pre-operative check-ups and PPE kits etc amounting to Rs 40,000 were borne by the parents.


